### **INDUSTRY REGISTRATION**



#### Q. What is MyWAVESFilmBazaar account?

MyWAVESFilmBazaar account allows you to -

- Register for WAVES Film Bazaar
- Save draft submissions, review, and make changes to your profile
  Apply to various WAVES Film Bazaar programmes
- Log in to complete and submit your application
- View completed submission forms
- Update your profile, photo, and contact details etc. for the Market Guide.

#### Q. How and when can I register as a delegate at WAVES Film Bazaar?

You can register as a delegate at WAVES Film Bazaar by filling out an online application form. Go to the "Sign Up" section of the website and create a MyWAVESFilmBazaar account.

You can apply for the various individual programmes (please check the individual programme sections on the website for application deadlines, eligibility criteria and requirements), or register as a delegate.

If you register online before the closing date, you can have your profile, contact details and photograph published in the Market Guide. Every delegate attending the Bazaar has access to this guide and is an essential networking tool.

The dates/deadlines for Delegate Registration are announced on the website.

#### Q. What does "passport-sized photo" mean?

It means your photograph must be: 2×2 inches in size, recently taken, in colour, front profile, .jpg format.

You can create an account on our website for free. However, you have to pay for Registration to attend the WAVES Film Bazaar. Registration to attend WAVES Film Bazaar is confirmed once we receive the payment.

#### Q. What is the registration fee for Film Bazaar?

#### Early Bird Registration | September 29th - October 19th, 2025

INR 18000 (11:59 PM IST)

#### Regular Registration | October 20th to November 9th, 2025

**INR 20000 (11:59 PM IST)** 

#### **Extended Registration / On Spot Registration**

November 10th 2025 onwards INR 25000 (11:59 PM IST)

#### Student Registration October 4th November, 2025 onwards INR 9000 (11:59 PM IST)

#### Q. Is the application fee refundable?

No. The application fee is non-refundable and non-transferable.

## Q. I want to register for the Waves Film Bazaar, what are the

requirements? If you want to register as -

- a) **Industry Delegate** upload a current passport-sized photo, a short profile and if you are representing a company, upload the company logo.
- b) **Student** upload a current passport-sized photo, a scan of valid photo ID, a government verified age proof, and a letter granting permission to attend the Bazaar signed and stamped by the college authorities on college letterhead.

- Please note that access to the Viewing Room is restricted. To confirm if you have access, please write to films@filmbazaarindia.com after you have registered successfully.

(Note: Registered Students will not be featured in Market Guide) **Should I be concerned?**

#### Q. Will I receive a receipt/invoice for my registration fee?

Yes. Once registration is complete, delegates can view and print their payment receipts from their *WavesFilmBazaar* account. Also, a copy of the same will be mailed to your registered email-id.

#### Q. I have made a mistake while filling the registration form. What should I do?

In case of any mistake that needs to be corrected post submission of the Registration Form, please DO NOT start a new application. Please get in touch with the team and send the corrections to <a href="mailto:registration@nfdcindia.com">registration@nfdcindia.com</a>.

#### Q. How do I know if I have access to the Viewing Room?

Viewing Room (VR) has restricted entry and allows only buyers, world sales agents, distributors, film festival directors/programmers, and representatives of digital platforms dealing with acquisitions to watch films from the VR Library. If you wish to know before the Film Bazaar whether you have access to the Viewing Room, you can write to films@filmbazaarindia.com after you have registered successfully.

# Q. If I've submitted my project to one of the labs, do I have to pay for the registration?

Please note that the delegate registration process is separate from your project submission process. Registration Pass/ Accreditation will be provided if your project gets selected for any of the verticals of Film Bazaar. To attend NFDC Film Bazaar, please log in to your wavesfilmbazaar account and register through the My Film Bazaar welcome page. You can also register as a delegate here -- Attend as Delegate.

For queries related to specific programmes please visit the website.

#### Q. What is the payment process?

Once you have filled in all required information in your online application form, you will be directed to a payment page where you can choose Credit/Debit Card or Netbanking or UPI.

## Q. I made the payment using Net Banking /UPI and there was a failure message. The amount has been debited from my account. What should I do?

In case the amount has been debited from your account, but you have received a failure message, kindly do not make another transaction. Write to us at registration@filmbazaarindia.com so that the Film Bazaar Team can guide you further.

## Q. I began the online registration process and left the form halfway. I now want to go back and complete my form/registration for Film Bazaar 2025. How do I do this?

To complete an incomplete Application/Registration you need to 'Login to your *WavesFilmBazaar* Account' by entering your username and password. On successful login, you shall be directed to your *WavesFilmBazaar* account page where you can select the relevant Application and complete your Registration. Please DO NOT start a new application.

## Q. I attended Film Bazaar last year and received a username and password. Can I still use it for Waves Film Bazaar?

Yes, you can use your old username and password to login. However, you need to register as a Delegate for Film Bazaar to access any information specific to the current edition of Film Bazaar.

# Q. I am already registered for the current edition of Waves Film Bazaar. A colleague from my company wants to join as well under the same company head. How can he/she apply?

Your colleague will have to register independently on our website and follow the same procedure that you followed for Delegate Registration. Once your colleague makes the payment and Registration is confirmed, he/she will automatically get listed under the same company.

## Q. I am unable to attend. Can I transfer my Delegate access to a colleague or receive a refund?

No. All registrations to Waves Film Bazaar are for an individual, non-transferable, and non-refundable under any circumstances including non-participation.

## Q. I want to attend Waves Film Bazaar only for a day or two. Will I still have to pay the entire registration fee?

Yes. Registration has to be done for the entire event. There are no daily passes available.
